Board Chair Beverly called the meeting to order at 7:32 am. A quorum of the Directors was present. Ms. Magwood was designated to take the minutes.

Consent Agenda

Mr. Beverly presented the Consent Agenda consisting of the minutes from the Nov 16, 2022, meeting. Mr. Lee moved to approve the minutes as presented. Ms. Fine seconded the motion. The motion passed unanimously.

Mr. Beverly congratulated Councilmember Marilyn Balcombe on her election to the County Council and welcomed her to the MCEDC Board.

Montgomery County Business Center Overview

Mr. Smith, Business Center Team Manager presented an overview of the services and resources provided by the Business Center. Specifically, one-on-one business guidance, including:

- Starting a business
- Expansion and growth support
- Relocation and site selection

- License and permitting assistance
- Connecting to business resource partners

Incubator Strategy Update

Ms. Semple provided an overview of the County's current incubator facilities located in Silver Spring Rockville, and Germantown. Ms. Semple noted the recommendations from the Study of Innovation Centers which focused on the Silver Spring center. She discussed MCEDC's role as a strong partner in leveraging business stakeholders and revitalizing and refocusing Montgomery County's incubator operations into a more comprehensive component of the County's entrepreneurship and innovation network. Dr. Kumar, a former incubator participant, and Mr. Lee recognized Ms. Semple and her team for their outstanding work with entrepreneurs through the incubator program.

Reports

Governance Committee Report

Mr. Tompkins reported that MCEDC is awaiting confirmation from the County Executive on the candidates recommended for Board appointments.

Fund Development Committee Report

Dr. Kumar reported that the Committee met last week and is working with staff to determine opportunities to attract funding for strategic initiatives.

President & CEO Report

County Council / Commerce Cabinet

Mr. Tompkins reported that there is a lot of activity with the introduction of the new Council and the establishment of the Council's Economic Development Committee. Mr. Tompkins suggested that the February meeting focus on aligning the County's Economic Development Strategic Plan with MCEDC's Workplan. He further noted that on February 6th the plan will be reviewed by the Economic Development Committee.

Marketing

Mr. Tompkins provided an update on the Be Next Marketing campaign noting that the campaign is taking real shape and initial reach and responses are very good. Mr. Tompkins reported that the bulk of the campaign will run from January through April with print, television, YouTube, and additional radio being added.

Legislative Session

Mr. Tompkins reported that the Maryland 445th Legislative Session commenced on January 11th and will run through April 10th. He also noted that he, Jerry Sanford, Lynne Benzion, and Laurie Boyer-Babb recently connected with then Lieutenant Governor-Elect Aruna Miller at the 2023 Maryland Economic Development Association (MEDA) Winter Conference in Annapolis where the Montgomery County resident was the keynote speaker. MCEDC attended the conference with public and private sector leaders sharing thoughts on economic development-related legislation that will be considered by the Maryland General Assembly during the 2023 session.

Business Development Report

Mr. Stewart reported on business development project outcomes over the last 18 months. The Committee asked questions and engaged in discussion about the status of the projects. Ms. Hsin requested that a written Business Development Report be included in the Board materials going forward.

Finance & Audit Committee/Treasurer's Report

Ms. Hsin presented the financial statements for the period ending November 30 and December 31, 2022. Ms. Hsin discussed budget variances and noted that previously restricted funds have been released from the balance sheet. Additionally, the Finance & Audit Committee reviewed and approved the 990 return. The return will be filed with the IRS before the end of January.

Ms. Hsin noted that the Single Audit is at the last stages of completion and is expected to be completed by the February meeting.

New Business

Ms. Hsin discussed the Board calendar and noted that the housing access and impact on economic development discussion did not take place. She suggested that the Board calendar be revisited to ensure that all proposed agenda topics are addressed before the end of the year.

Closed Session

Ms. Larsen moved to adjourn the meeting and Ms. Fine seconded the motion.

The meeting was adjourned at 9:15 am.
